Sir/Madam,

With reference to the above mentioned subject after detailed scrutiny of the documents including affidavits supplied by your school management and the recommendations made by DEO (Sec. Edu.) Ludhiana and DPI (Sec. Edu.) Punjab, the No Objection Certificate is being issued by the Punjab Govt. on the following conditions: -

- (1) On the basis of any complaint/inspection in future, if any fact comes into the knowledge of Punjab Govt. that you have given false information at the time of applying for N.O.C. and the directions issued by Punjab Govt. from time to time have not been fully obeyed and the conditions laid down in the affidavits are not complied with then under these circumstances the No Objection Certificate so issued can be withdrawn at any time.
- (2) Teaching of Punjabi language up to class X will be compulsory in your school and CBSE, New Delhi will make due arrangements to conduct the exam of Punjabi in such schools. In case this condition is not obeyed the N.O.C. so issued will be withdrawn.
- (3) After getting affiliation from CBSE, New Delhi your school management will pay salaries to the teaching and non-teaching staff at par with Govt. Employees. In case it is not done so the N.O.C. can be withdrawn at any time.
- (4) You and your management will make sure that in case any information is demanded by your District Education Officer or any Senior officer of Education Department then you will supply the required information and will co-operate with him.
